## Taxes

In Ontario, most goods and services purchased are subject to a 13% Harmonized Sales Tax (or HST). This is comprised of 8% provincial tax plus 5% federal tax. Prior to 2007, visitors to Canada could apply to obtain the federal portion of the tax refunded upon their return to the home country. However, this refund is no longer available except for accommodation or camping charges for eligible tours.

There is also a 4% Municipal Tax on room charges.

#### Security Charges

All motels, inns, etc. will apply a security charge to your credit card at the time of check-in. The amount varies with each hotel. This charge will be refunded to your card in 3-5 days after check-out.

#### Smoking

There are no longer designated smoking rooms. ANY smoking in your room can result in a \$250 charge to your bill. Simply opening a window will not be sufficient.
